In November 2021, President Biden signed a \$1 trillion bipartisan infrastructure package into law. The new law includes significant investment and funding opportunities for cooperatives and the communities they serve. Included with the legislation are 32 programs in five broad categories that may make resources available to Central Electric Cooperative (CEC), either directly or indirectly. However, much work still needs to take place before federal agencies begin funding infrastructure projects. The Department of Energy, Department of Agriculture, Federal Communications Commission. and other agencies are working to outline the programmatic elements of these programs. The timeline for when and how federal agencies work to outline these programs will vary from agency to agency.

Since the passage of the legislation, you may have seen news reports about the various funding opportunities available. Given the questions we have started to receive, many of you have an interest in what CEC is doing and what part we may play in any project. As I write this article, none of the 32 programs have completed their planning for implementation. Our statewide and national associations, PREA and NRECA, are monitoring the status of the programs and keeping us updated, so we can take advantage of opportunities as they arise. The programs that are furthest along in planning are broadband and electric vehicle infrastructure.

CEC is not waiting until the project planning is complete to begin our efforts. In addition to monitoring the status, we have been meeting with other local agencies to identify how we can participate with their

efforts to provide the best opportunity for our area to receive funding. CEC is also identifying grid resiliency projects that would impact our system. We have, and continue to meet, with those creating the guidelines to provide input into how funding would benefit our area the most. We recently participated in a grant proposal with a local economic development group that, while ultimately unsuccessful, provided a channel for future submissions.

Our efforts have been focused on the areas of electric vehicle infrastructure, grid resiliency projects and solar generation interconnection to the larger grid. Our overarching goal is to be prepared to take action as soon as resources are available. Pennsylvania has established a broadband agency that will distribute funding throughout the state to those building broadband infrastructure. Similar efforts are underway at the state level for electric vehicle infrastructure. A virtual forum was held at the end of March that included PennDot. the Eastern Pennsylvania Alliance for Clean Transportation, Pittsburgh Regional Clean Cities, Drive Electric Pennsylvania, electric utilities, and your cooperative to discuss electric vehicle infrastructure and funding.

There are certainly significant potential funding opportunities that could benefit CEC and the communities we serve in a wide variety of areas. What is less certain is which of these opportunities will actually come to be and in what time

frame they will be available. We anticipate the need to act quickly as programs are rolled out. CEC's relationships with PREA, NRECA, state legislators, federal legislators and local agencies puts us in a unique position to potentially have better access to the project funding. This coupled with our advanced preparations and planning will give CEC members the best possibility of benefitting from these resources.

As things proceed, we will continue to keep you informed about what opportunities come to our area and what part we will play in them. I appreciate your interest in this important subject and thank you for your support in our efforts.

Because electric co-ops operate at cost, any excess revenues (called margins) are allocated and retired to members in the form of capital credits.

Spring Digging

The upcoming spring and summer months often have folks planning tasks and projects. Whether you are planting trees, doing landscape work, completing a DIY project, or building an addition, your projects may include excavation work – Think Before You Dig! Call 811.

Underground utility strikes are dangerous and costly events — with many incidents damaging electric or gas lines, which can affect everyone in the area. The following points are some excavation best practices to avoid utility strikes.

- Always call 811 to have lines marked prior to digging. 811 notifies utility companies of your plans to dig and sends someone to mark any utilities in that area.
- Do not dig with machinery or pointed tools within the "tolerance zone" around marked utilities typically 18 inches on either side of the outside edge of the underground facility on a horizontal plane. Use "soft digging techniques," such as hand digging with blunt edged tools or vacuum excavation.
- Stop excavation and call 811 again if unmarked utilities are discovered or utilities are not found where they are marked.
- When working in a facility or on private

property that has privately installed lines, the lines most likely will not be part of the 811 system. Use other methods, such as ground penetrating radar, private locators, as-built drawings, and individuals familiar with the facility to locate lines before excavating.


There are many hazards to consider when excavating. Having a proactive approach prior to digging is important to avoid underground utility strikes. Please remember there are many other hazards and best practices not mentioned here.

I regularly use this space to share ways to reduce electricity usage – and in turn save you money. This month, I want to share a way to save time and money, all while gaining convenience — Paperless Billing!

Members can access SmartHub, our online account center and mobile app, 24/7. Once enrolled, you will receive monthly emails when your bill is available. The email includes the bill amount and due date, as well as a link to access your bill online anytime, anywhere. In addition, you will also have a link to access this newsletter.

While the number of members enrolled in SmartHub is high, those who have committed to

strictly online access remains low. I encourage you to unclutter your mailbox, save stamps and go paperless! All newly enrolled paperless billing members will receive a \$10 one-time bill credit.

In addition, all members who sign up for paperless billing by May 16 will be entered into a drawing for a chance to win a \$100 bill credit — CEC will give away five, \$100 bill credits!

If you want to take the hassle out of bill paying, enroll in our auto-pay program for another \$10 one-time bill credit. Through this program, your monthly amount can be automatically deducted from a bank account or credit card on the due date of the bill—saving you time and the burden of a late charge.

Members who wish to go paperless can opt-in within SmartHub. If you are new to SmartHub, sign up at www.central.coop or call 800-521-0570.

CEC employees and directors, along with members of their immediate families, are ineligible to win the bill credits.

Recipe of the Month

Banana Coconut Cake

Topping Ingredients:

- 1/2 cup shredded coconut
- 1/2 cup brown sugar
- 1 tsp cinnamon
- 1/2 tsp ginger

Directions:

Mix ingredients together.

Cake Ingredients:

- 1/2 cup butter
- 1 tsp baking soda
- 1 tsp vanilla
- 1/2 tsp salt

- 1 cup sugar

- 3 eggs
- 1 tsp baking powder
- 1 cup ripe bananas, mashed
- 1/2 cup yogurt or buttermilk

Cake Directions:

Cream butter and sugar. Beat eggs in one at a time. Add bananas, buttermilk or yogurt, and vanilla. Mix dry ingredients together, then add to mixture. Pour half the batter in a nine inch pan then spread half the topping on top. Add remaining batter then topping. Bake at 350 degrees for about 50 minutes.
